DEA Number Required for Prescribers

Providers who administer, prescribe, or dispense pharmacy medications or durable medical equipment picked up at the pharmacy must be registered with the U.S. Drug Enforcement Administration (DEA) and are required to include their DEA license information with their enrollment information. A DEA license, which is valid for three (3) years, ensures providers understand and comply with federal laws.

When completing an enrollment application or update for a provider with prescribing privileges in the Montana Program for Automating and Transforming Healthcare Provider Services Portal (PSP), be aware that the DEA license questions are presented in a single line question format versus the standard grid format used for other licensure types in the PSP.

DEA license questions are presented under the Credentials Menu option on the Licensing, Certifications & Accreditations tab. Each question requires a Yes/No response. Prescribing providers enrolling with Montana Healthcare Programs should answer Yes to all applicable questions on this tab.

A missing DEA license can result in a longer enrollment process time.

If you inadvertently answered No to the questions for the DEA license and have already submitted your enrollment/update, the current update will need to be processed and then a new update will need to be created. On the new update you create, the DEA question will need to be answered "Yes" with uploaded supported documentation.

When updating or revalidating a provider enrollment record, verify that the valid provider DEA license is on file. This will help prevent claim denials.
